
Reference is made to the above captioned tender awarded in favour of Prevarti Art Restoration and Conservation and to your letter of 1st June 2010.

ReCoop is hereby objecting and appealing from the decision to award the tender to Prevarti Art Restoration and Conservation on the basis that misleading information was provided in the tender document submitted by Prevarti Art Restoration and Conservation in the sense that Professor Mario Buhagiar Ph.D., Head, Department of History of Art, University of Malta, was included as art-historical consultant of the said Prevarti Art Restoration and Conservation.

This fact has definitely had a bearing on the outcome of the tender. It is now confirmed that in actual fact Professor Mario Buhagiar, as appears from the attached document, is not a consultant to Prevarti Art Restoration and Conservation. This is a serious breach of the technical and administrative submissions of the tender dossier.

In view of the above, we kindly request the revocation of the above mentioned decision and that this tender be award to ReCoop Ltd (The conservation and Restoration Co-Operative), seeing that ReCoop has satisfied the technical and administrative requirements of the tender dossier.
